- Director Hickey reported that Trustee Ed Anthony, Trustee Roger Peterson, and Mayor Deidre Petrosky were all nominated and reelected to continue in their current positions for the years 2024-2025 by the EMA Advisory Board on January 10, 2024.
- Director Hickey requested that the executive board provide him with verbal consent to purchase Four (4) conference tables, two (2) half-moon conference table ends, and ten (10) mesh conference chairs for the situation/conference room. The old conference table was donated to the Trumbull County Combined Health District due to the inability to make the conference room more flexible for various uses. The new tables can be set up in the conference style or be broke out for individual works stations if needed.
