EMA DIRECTORS OPERATIONAL UPDATE

Director Hickey provided a written report for October 2023: (See Attachment) A brief overview of the director's report was conducted.

- Participated in multiple community events, in order to promote the TCEMA and all the services that are provided by our office.
- Participated in the three (3) day Ohio Department of Health full scale exercise. The Emergency Operations Center was opened and staffed all days of the exercise.
- Working with the TC auditor and prosecutors office to finalize bid packages for the mobile command post.
- Hosted the NEO EMA Directors meeting at the office.
- Cash request for FY22 EMPG completed for the amount of \$21,508.95
- Multiple requests and deployments of the drones by law enforcement and fire departments.
- Attended drone pilot certification class in Geauga County.

HAZMAT

- Written report submitted, see attached.
- Held one (1) training/meeting night.
- Chief attended drone pilot certification class in Geauga County.
- Responded to four (4) calls for service.

FIRE INVESTIGATIVE UNIT

LEPC

No meeting held since October quarterly meeting, next meeting in January 2024.

OLD BUSINESS

- Update provided on bid process for proposed mobile command post for the county.
- Unable to schedule meeting with the prosecutor, concerning HazMat stipend program. Will continue to work on scheduling one as soon as possible.
- Discussion conducted concerning the proposed hiring of a full time staff member in 2024. Director Hickey provided data and figures to show that due to the high costs associated with having another full time staff member (Salary & Benefits) it would not be feasible to hire a full time staff employee at this time. Director Hickey provided documentation showing that even brining an additional person on at \$42,000.00 per year salary, the total cost of that employee would be in excess of \$80,000.00 with salary and benefits. The EMA budget can not support this at this time, and the director advised he would pursue looking at a part time employee, possibly at 20 hours a week. Further discussion will be held during the first quarter of 2024.
- Discussion was conducted concerning the 2024 draft budget for the EMA. Director Hickey will send out the draft budget once completed, and have the final draft ready for approval at the January 11, 2024 meeting.

NEW BUSINESS
